

Campers Information Sheet and Registration

Please fill out this information sheet and read through everything thoroughly. For ease, please fill out separate forms for different children to ensure the camper is placed in the right camp.

Camp Policies:

- 1) All campers are expected to behave in an appropriate manner and to respectfully follow rules and instructions. Campers must be interested in participating in all activities. There will be no alternative activities provided to campers who wish not to participate. They will be dismissed accordingly. By enrolling in camp, the camper and the camper's parents acknowledge that good behavior is necessary and that any camper's failure to act accordingly may result in the camper being dismissed from the camp. The parents or legal guardians of any camper who is dismissed for disciplinary problems shall be responsible for picking up their camper or arranging appropriate transportation home for such camper.
- 2) The camper's parents, legal guardians, or authorized adults must drop off the camper between the time allowance listed. If an adult is early for drop off, they must wait until camp begins. If an adult is early for pick up, they must allow their camper to clean up until camp ends. There is zero tolerance for late drop offs or late pick ups. Refunds cannot be made during the Camp for inability to attend or last minute absences.
- 3) If the camper cannot attend a full week of camp we do not adjust pricing for individual circumstances, but we can transfer the camper to a different session if there is room in the Camp.
- 4) Campers are responsible for keeping their space clean during Camp and they are responsible for cleaning up the studio with the instructor before Camp dismisses. Campers are not excused to leave before the studio is cleaned up. Parents or legal guardians who are early to pick up the camper are expected to join cleaning or wait in their car.
- 5) The Oxford Arts Alliance and all other parties involved may not be trained in special needs accommodations, therefore we are not a special needs camp. We ask that the camper's parent or legal guardian provide any information that will ensure a good experience for the camper below and comply to all policies and clauses. If the camper has physical disabilities, we ask that the camper's parent or legal guardian request a visit of our camp location before registering the camper.

*Tuition Policy: I understand that all tuition is paid in advance. A \$20 deposit fee + a \$5 processing fee will be withheld if students cancel prior to one week before the start of camp. Tuition may not be refunded with 7 days of camp. Refunds cannot be made during the week of camp for sickness or inability to attend camp for last minute absences.

*Disciplinary Actions: All campers must comply with our camp policies. Campers must be interested in participating in all activities. There will be no alternative activities provided to campers who wish not to participate. They will be dismissed accordingly. By enrolling in camp, the camper and the camper's parents acknowledge that good behavior is necessary and that any camper's failure to act accordingly may result in the camper being dismissed from the camp. parents or legal guardians of any camper who is dismissed for disciplinary problems shall be responsible for picking up their camper or arranging appropriate transportation home for such camper.

I hereby accept all responsibility for any accident, injury, or illness that may occur in conjunction with this program. I am releasing and hold harmless Oxford Arts Alliance and all other parties involved from any and all claims, costs, liabilities and expenses including all judgments, attorney's fees and court costs.

__ *Voluntary Consent to Participate: I, the undersigned, do hereby acknowledge that my child, the participant listed above, is physically fit and in a condition to fully participate in all camp activities and it is my wish for my child to participate in all camp activities. I recognize that I must make the Oxford Arts Alliance and all other parties involved aware of any conditions my child has that may inhibit his or her ability to participate in the Camp.

__ *Medical Insurance Coverage: I acknowledge that neither the Oxford Arts Alliance nor all other parties involved shall provide medical insurance coverage to my child. My child is covered under my insurance policy. Additionally, I acknowledge that all of the information provided above is current and correct. I am executing this waiver and release for my child/me to participate in this program. I have read and agreed to all terms listed.

__ *Medical Treatment: If my child is injured during their participation in any camp activities, Oxford Arts Alliance may request medical services. By taking such action, the Oxford Arts Alliance and all other parties involved are not admitting any liability to provide or to continue to provide any such services. Should my child require transport to a medical facility as a result of an injury, I am financially responsible for such transportation and medical treatment costs. If my child is injured during camp, it is my child's responsibility to notify the Oxford Arts Alliance and all parties involved immediately. I hereby hold harmless and agree to indemnify the Oxford Arts Alliance and all parties involved from any claims, causes of action, damages and/or liabilities, arising out of or resulting from said medical treatment. I further agree to accept full responsibility for any and all expenses, including medical expenses that may derive from any injuries to my Child that may occur during his/her participation in the Camp.
